

## PRIVACY POLICY

### Our Commitment to You

Armstrong Advisory Group Inc. (“AAG” or the “Advisor”) is committed to safeguarding the use of personal information of our Customers and Prospects (also referred to as “you” and “your”) that we obtain as an Investment Advisor, as described here in our Privacy Policy (“Policy”).

Our relationship with you is our most important asset. We understand that you have entrusted us with your private information, and we do everything that we can to maintain that trust. AAG (also referred to as “we”, “our” and “us”) protects the security and confidentiality of the personal information we have and implements controls to ensure that such information is used for proper business purposes in connection with the management or servicing of our relationship with you.

AAG does not sell your personal information to anyone. Nor do we provide such information to others except for discreet and reasonable business purposes in connection with the servicing and management of our relationship with you, as discussed below.

Details of our approach to privacy and how your personal information is collected and used are set forth in this Policy.

### Why you need to know?

Registered Investment Advisors (“RIAs”) must share some of your personal information in the course of servicing your account. Federal and State laws may give you the right to limit some of this sharing and require RIAs to disclose how we collect, share, and protect your personal information.

#### FACTS

What does Armstrong Advisory Group, Inc. do with your personal information?

#### WHY?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

## What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and date of birth
- Driver's license number and account information (including other institutions)
- E-mail address and investment experience, risk tolerance, income and expenses.

When you are *no longer* our customer, we continue to share your information as described in this notice.

## How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Armstrong Advisory Group chooses to share; and whether you can limit this sharing.

<b>Who is providing this notice?</b>	Armstrong Advisory Group, a Registered Investment Adviser.

<b>What we do</b>	
<b>How does Armstrong Advisory Group protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. In addition, our technology vendors provide security and access control over personal information and have policies relating to data transmission.
<b>How does Armstrong Advisory Group collect my personal information?</b>	We collect your personal information, for example, when you <ul style="list-style-type: none"> <li>■ Open an account or provide account information</li> <li>■ Discuss your account or seek advice about investments</li> <li>■ Tell us about your investment or retirement portfolio</li> <li>■ Enter into an investment advisory contract with us</li> </ul>
<b>Why can't I limit all sharing?</b>	Federal law gives you the right to limit only <ul style="list-style-type: none"> <li>■ sharing for affiliates' everyday business purposes —information about your creditworthiness</li> <li>■ affiliates from using your information to market to you</li> <li>■ sharing for non-affiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>
<b>How long does Armstrong Advisory Group keep my personal information?</b>	We retain your information in physical and electronic format. <p>If you are an existing or former customer, we retain your information for the entire duration of us servicing your account and indefinitely following account closing.</p> <p>If you shared your personal information with us while considering our services but have not become a customer ("prospect"), we retain your information indefinitely unless you specifically request disposal of such records.</p> <p>Please note that due to the applicable industry marketing rules, certain records must be retained by us for at least five years, thus, cannot be disposed of even at your request. Should you ask us to destroy such records, we will advise you accordingly.</p>

Definitions	
<b>Affiliates</b>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>■ <b>Armstrong Advisory Group is affiliated with Armstrong Insurance Group, Inc. and with B1 Insurance Agency, LLC (by common officer only),</b></li> </ul>
<b>Non-affiliates</b>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>■ <b>Armstrong Advisory Group does not share with non-affiliates so they can market to you.</b></li> </ul>
<b>Joint marketing</b>	<p>A formal agreement between non-affiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>■ <b>Armstrong Advisory Group doesn't jointly market.</b></li> </ul>
Other important information	
<p>This privacy notice has been prepared in accordance with federal law consistent with the Gramm-Leach-Bliley Act (GLBA). You may have other privacy protections under state laws. To the extent these state laws apply, we will comply with them with regard to our information disclosure practices.</p> <p>Since the enactment of GLBA, there has been considerable activity in state legislatures on financial privacy issues. Some states have laws that are even more protective of consumer privacy than under GLBA. For example, certain states have adopted a requirement for you to approve the sharing of information in advance, otherwise known as an "opt-in" choice. If you live in an "opt-in" state (e.g., California, Massachusetts, Maine, Alaska, North Dakota or Vermont), then we will require your consent to share your information with unaffiliated third parties who are not servicing your account. State requirements vary and may change without notice.</p> <p>Please note that, in order to comply with applicable laws and legal requirements, we may disclose information to government entities, self-regulatory organizations, or other third parties in response to court orders, subpoenas, government inquiries, or other mandatory legal processes.</p>	

## State-Specific Regulations – Massachusetts Opt - In

In response to Massachusetts law, the Client must “opt-in” to share non-public personal information with non-affiliated third parties before any personal information is disclosed. Client opt-in is obtained through the Client’s execution of authorization forms provided by the third parties, by executing an Information Sharing Authorization Form, or by other written consent by the Client, as appropriate and consistent with applicable laws and regulations.

## SMS/Text Messaging

Please note that we may use your mobile number to communicate with you via SMS/text message, including for marketing and promotional purposes. We may contact you about products, services, information, and news that may be of interest to you through the use of third party service providers (such as Zoom). For the avoidance of doubt, your mobile number and consent to receive text messages from us will not be shared with third parties or affiliates for those third parties’ or affiliates’ own independent marketing or promotional purposes. Any information we share with third parties or affiliates excludes your mobile number and consent to receive text messages from us (except to the extent necessary for third party service providers such as Zoom to provide services to us).

## Changes to our Privacy Policy

We will send you a copy of this Policy annually for as long as you maintain an ongoing relationship with us.

Periodically we may revise this Policy and will provide you with a revised Policy if the changes materially alter the previous Privacy Policy. We will not, however, revise our Privacy Policy to permit the sharing of non-public personal information other than as described in this notice unless we first notify you and provide you with an opportunity to prevent the information sharing.
